INSTRUMENT OF RATIFICATION

TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services and its Protocols 1 and 2 was signed on 12 November 2010 in Brunei Darussalam;

WHEREAS, the Agreement grants a Contracting Party the right to fly across the territory of another party without landing, and the right to make stops in that territory for non-traffic purposes;

WHEREAS, it allows the designated airline(s) to operate from any points in the territory of the Contracting Party designating the airline(s) via any intermediate points to any points in the territory of any other Contracting Party and to any points beyond in any combination or order, provided that all the points are international airports;

WHEREAS, it also provides that each Contracting Party shall have the right to designate as many airlines as it wishes for the purpose of conducting international air services in accordance with the agreement and to withdraw or alter such designation;

WHEREAS, Protocol 1 provides that the designated airline(s) of each Contracting Party shall be allowed to operate the agreed services from any cities with international airports in its territory to any cities with international airports in the territory of the other Contracting Parties and vice-versa with full third (3rd) and fourth (4th) freedom traffic rights, provided that in no case shall the origin and destination points both be capital cities and that such operations shall be without limitations on capacity, frequency and aircraft type;

WHEREAS, Protocol 2 provides that the designated airline(s) of each Contracting Party shall be allowed to exercise fifth (5th) freedom traffic rights for the agreed services between any cities with international airports in the territories of other Contracting Parties;

WHEREAS, the Agreement and its Protocols 1 and 2 shall enter into force on the date of the deposit of the third Instrument of Ratification or Acceptance with the Depositary and shall become effective only among the Contracting Parties that have ratified, or accepted it, pursuant to Article 19 (3) thereof;

NOW, THEREFORE, be it known that I, BENIGNO S. AQUINO III, President of the Philippines, after having seen and considered the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services and its Protocols 1 and 2, do hereby ratify and confirm the same and each and every article and clause thereof.
