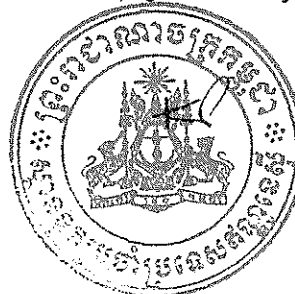

INSTRUMENT OF RATIFICATION

WHEREAS, the Royal Government of the Kingdom of Cambodia has signed the Protocol to the ASEAN Charter on Dispute Settlement Mechanisms on the Eighth Day of April in the Year Two Thousand and Ten, in Ha Noi, Viet Nam;

WHEREAS, the article 19 paragraph 4 of the Protocol stipulates that this Protocol shall enter into force on the day following the date of deposit of the tenth instrument of ratification with the Secretary-General of ASEAN;

AND WHEREAS, His Majesty the King of Cambodia promulgated the Protocol to the ASEAN Charter on Dispute Settlement Mechanisms on 14 June 2014;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Protocol, hereby undertakes to faithfully perform and carry out all the stipulations therein contained;

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Deputy Prime Minister and Minister of Foreign Affairs and International Cooperation of the Kingdom of Cambodia.
