INSTRUMENT OF RATIFICATION
AGREEMENT ON THE PRIVILEGES AND IMMUNITIES
OF THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS

WHEREAS the Agreement on Privileges and Immunities of the Association of Southeast Asian Nations (hereinafter referred to as "the Agreement") was signed by the Government of Brunei Darussalam in Cha-am Hua Hin, Thailand, on 25 October 2009;

AND WHEREAS Article 13 of the Agreement provides that the Agreement is subject to ratification by all Member States in accordance with their respective internal procedures;

NOW THEREFORE I, Mohamed Bolkiah, Minister of Foreign Affairs and Trade of Brunei Darussalam, declare that the Government of Brunei Darussalam, having considered the Agreement, hereby ratifies the same and undertakes faithfully to perform and carry out the obligation therein contained;

IN WITNESS WHEREFOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Minister of Foreign Affairs and Trade of Brunei Darussalam.
