INSTRUMENT OF RATIFICATION

WHEREAS the Government of the Kingdom of Thailand, being an ASEAN Member State, signed the Protocol to Implement the Seventh Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services on 3 May 2016;

WHEREAS Paragraph 6 of the aforesaid Protocol stipulates that this Protocol and the commitments set out in the Annexes shall enter into force one hundred and eighty (180) days after the date of its signing;


WHEREAS Paragraph 7 of the aforesaid Protocol stipulates that Member States undertake to complete their internal procedures of ratification or acceptance for the entry into force of this Protocol and the commitments set out in the Annexes; and

WHEREAS Paragraph 8 of the aforesaid Protocol stipulates that Each Member State shall, upon the completion of its internal procedures of ratification or acceptance of this Protocol and the commitments set out in the Annexes, deposit its Instrument of Ratification or Acceptance with the Secretary-General of ASEAN who shall notify other Member States of such deposit;

THE GOVERNMENT OF THE KINGDOM OF THAILAND, having considered the aforesaid Protocol, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

DONE at the Ministry of Foreign Affairs, Bangkok, this 2nd Day of November in the Year Two thousand Five hundred and Fifty-nine of the Buddhist Era, corresponding to the Year Two thousand and Sixteen of the Christian Era.
