The Embassy of the Lao People's Democratic Republic avails itself of this opportunity to the ASEAN Secretariat in Jakarta the assurances of its highest consideration.

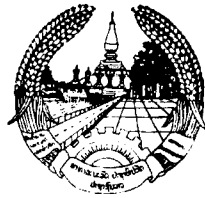
