INSTRUMENT OF ACCEPTANCE

to the Memorandum of Understanding on the Association of Southeast Asian Nations' Air Services Engagement with Dialogue Partners

WHEREAS the Memorandum of Understanding on the Association of Southeast Asian Nations' Air Services Engagement with Dialogue Partners was signed by the duly authorized representative of the Government of the Lao People's Democratic Republic, at Brunei, Darussalam, on 12nd November 2010;

AND WHEREAS Paragraph 7 of the Memorandum of Understanding stipulates that this Memorandum of Understanding shall enter into force once all ASEAN Member States have notified the Secretary-General of ASEAN in writing of their completion of internal formalities. The date of entry into force for this Memorandum of Understanding shall be the date the last written notification is received. The Secretary-General of ASEAN shall notify ASEAN Member States of the entry into force of this Memorandum of Understanding. The Memorandum of Understanding shall enter into provisional effect upon signature for ASEAN Member States where their internal formalities permit;

NOW THEREFORE I, Thongloun SISOULITH, Deputy Prime Minister and Minister of Foreign Affairs, declare that the Government of the Lao People's Democratic Republic, having considered the said Memorandum of Understanding, accepts the same and undertakes faithfully to perform and carry out the stipulations therein contained.

IN WITNESS WHEREOF, I have signed and sealed this Instrument of Acceptance at Vientiane, Lao People's Democratic Republic, on 21 October 2011.
