**INSTRUMENT OF RATIFICATION**

**WHEREAS**, Protocol (3) on Unlimited Third and Fourth Freedom Traffic Rights between the ASEAN Sub-regions, which forms an integral part of the ASEAN Multilateral Agreement on Air services, was signed in Manila, the Republic of the Philippines on 20 May 2009;

**AND WHEREAS**, the Article 5 (2) of the Protocol (3) stipulates that this Protocol is subject to ratification or acceptance by the Contracting Parties and, the Instruments of Ratification or Acceptance shall be deposited with the Depository;

**NOW THEREFORE**, I, Wunna Maung Lwin, Union Minister for Foreign Affairs of the Government of the Republic of the Union of Myanmar, do hereby declare that the Government of the Republic of the Union of Myanmar, having considered the above-mentioned Protocol, ratifies the same and undertakes faithfully to perform and carry out all the stipulations therein contained;
