INSTRUMENT OF RATIFICATION

Protocol 1 Designation of Transit Transport Routes and Facilities and its Annex of List of Transit Transport Routes

WHEREAS the Protocol 1 - Designation of Transit Transport Routes and Facilities and Its Annex of List of Transit Transport Routes to implement the ASEAN Framework Agreement on the Facilitation of Goods in Transit was signed on 8 February 2007 in Bangkok, Thailand;
