**INSTRUMENT OF RATIFICATION
OF THE PROTOCOL 2 ON UNLIMITED FIFTH FREEDOM
TRAFFIC RIGHTS BETWEEN ANY ASEAN CITIES**

WHEREAS, the Royal Government of Cambodia has signed the Protocol 2 on Unlimited Fifth Freedom Traffic Rights between any ASEAN Cities on 12 November 2010, in Bandar Seri Begawan, Brunei Darussalam;

WHEREAS, the article 4 paragraph 2 of the Protocol provides that this Protocol is subject to Ratification or Acceptance by the Contracting Parties who have ratified or accepted this Agreement;

AND WHEREAS, His Majesty the King of Cambodia ratified the above-mentioned Protocol on 26 December 2012;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Protocol, undertakes to faithfully perform and carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
