INSTRUMENT OF RATIFICATION

WHEREAS the Kingdom of Thailand is a Contracting Party to the Protocol to the ASEAN Charter on Dispute Settlement Mechanisms, signed on 8 April 2010 at Hanoi, the Socialist Republic of Viet Nam;

WHEREAS Article 19 (2) of the aforesaid Protocol stipulates that this Protocol shall be subject to ratification by all Member States in accordance with their respective internal procedures; and

WHEREAS Article 19 (3) of the aforesaid Protocol stipulates that the Instrument of Ratification shall be deposited with the Secretary-General of ASEAN who shall promptly notify all Member States of each deposit;

THE GOVERNMENT OF THE KINGDOM OF THAILAND, having considered the aforesaid Protocol, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Deputy Prime Minister and Minister of Foreign Affairs of the Kingdom of Thailand.

DONE at the Ministry of Foreign Affairs, Bangkok, this th 24 Day of June in the Year Two thousand Five hundred and Fifty-eight of the Buddhist Era, corresponding to the Year Two thousand and Fifteen of the Christian Era.
