WHEREAS the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services was opened for signature at Brunei Darussalam on 12 November 2010,

AND WHEREAS the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services has been signed on behalf of the Government of the Republic of Singapore on 12 November 2010,

AND WHEREAS Paragraph 2 of Article 19 of the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services provides that it shall be subject to ratification or acceptance by the Contracting Parties,

NOW THEREFORE I, George Yong-Boon Yeo, Minister for Foreign Affairs, declare that the Government of the Republic of Singapore, having considered the abovementioned agreement, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained.
