

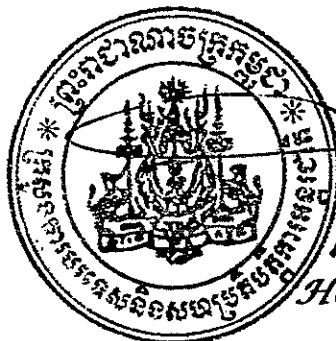
*WHEREAS, the article 31 paragraph 1 of the Agreement provides that this Agreement is subject to ratification or acceptance by the Contracting Parties;*
