KNOW YE, that whereas, the Protocol to Implement the Eighth Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services was signed on 20 December 2013 in Pakse, Lao PDR;

WHEREAS, the Protocol is mindful of the targets and the timelines of the ASEAN Economic Community Blueprint adopted at the 13th ASEAN Summit that provided for the liberalization of trade in services; and
