**INSTRUMENT OF RATIFICATION  
OF THE PROTOCOL TO IMPLEMENT THE SIXTH PACKAGE OF COMMITMENTS  
ON FINANCIAL SERVICES UNDER THE ASEAN FRAMEWORK AGREEMENT ON SERVICES**

**WHEREAS**, the Royal Government of the Kingdom of Cambodia has signed the Protocol to Implement the Sixth Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services in Kuala Lumpur, Malaysia on 20 March 2015;

**WHEREAS**, the paragraph 8 of this Protocol provides that each Member State shall, upon the completion of its internal procedures of ratification or acceptance of this Protocol and the commitments set out in the Annexes, notify the ASEAN Secretariat in writing;

**AND WHEREAS**, His Majesty the King of Cambodia promulgated the Protocol to Implement the Sixth Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services on 23 November 2016;

**NOW THEREFORE**, the Royal Government of Cambodia, having considered the aforesaid Protocol, hereby undertakes to faithfully perform and carry out all the stipulations therein contained;

**IN WITNESS WHEREOF**, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
