INSTRUMENT OF RATIFICATION

OF THE PROTOCOL ON THE LEGAL FRAMEWORK TO IMPLEMENT THE ASEAN SINGLE WINDOW

WHEREAS, the Royal Government of the Kingdom of Cambodia has signed the Protocol on the Legal Framework to Implement the ASEAN Single Window in Hanoi, Socialist Republic of Vietnam on 4 September 2015;

WHEREAS, the article 25 paragraph 1 of the Protocol provides that this Protocol shall enter into force, after all Member States have notified or, where necessary, deposited instruments of ratifications with the Secretary-General of ASEAN upon completion of their internal procedures, which shall not take more than one hundred and eighty (180) days after the signing of this Protocol;

AND WHEREAS, His Majesty the King of Cambodia promulgated the Protocol on the Legal Framework to Implement the ASEAN Single Window on 19 November 2016;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Protocol, hereby undertakes to faithfully perform and carry out all the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
