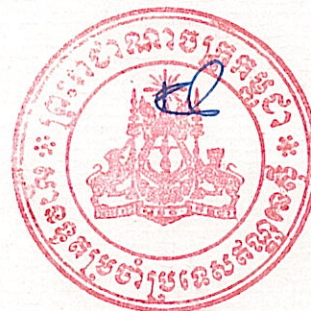
- 1. The ASEAN Multilateral Agreement on the Full Liberalization of Air Freight Services;*

of the ASEAN Multilateral Agreement on the Full Liberalization of Air

*WHEREAS, the Royal Government of Cambodia has signed the above mentioned Protocols on 20 May 2009 in Manila, Philippines;*

*WHEREAS, the article 7 of the Protocol 1 and the article 6 of the Protocol 2 of the agreement provide that the Instruments of Ratification or Acceptance shall be deposited with Depository who shall promptly inform each Contracting Party of such deposit;*

*AND WHEREAS, His Majesty the King of Cambodia ratified the above mentioned Protocols on 09 February 2011;*

*NOW THEREFORE, the Royal Government of Cambodia, having considered the above-mentioned Protocols, undertakes faithfully to carry out the stipulations therein contained;*

*IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.*
