Acceptance shall be deposited with the Secretary-General of ASEAN who shall  
promptly inform each Contracting Party of such deposit;*

*AND WHEREAS, His Majesty the King of Cambodia ratified the above  
mentioned Protocols on 09 February 2011;*

*NOW THEREFORE, the Royal Government of Cambodia, having  
considered the above-mentioned Protocols, undertakes faithfully to carry out the  
stipulations therein contained;*
