INSTRUMENT OF ACCEPTANCE

Framework Agreement on Multimodal Transport

WHEREAS the ASEAN Framework Agreement on Multimodal Transport was signed by the duly authorized representative of the Government of the Lao People's Democratic Republic, in Vientiane, Lao PDR on 17th November 2005,

AND WHEREAS Article 41, Paragraph 2, of the Agreement stipulates that the Agreement shall enter into force upon the thirtieth day after the deposit of the second Instrument of Ratification or Acceptance, and shall become effective only among the Member countries that have ratified or accepted it. For each Member Country ratifying or accepting this Agreement after the deposit of the second Instrument of Ratification or Acceptance, this Agreement shall enter into force on the thirtieth day after the deposit of its Instrument of Ratification or Acceptance,

NOW THEREFORE I, Thongloun SISOU LITH, Deputy Prime Minister, Minister of Foreign Affairs, declare that the Government of the Lao People's Democratic Republic, having considered the said Agreement, accepts the same and undertakes to faithfully perform and carry out the provisions therein contained.
