INSTRUMENT OF RATIFICATION



PIAGAM PENGESAHAN

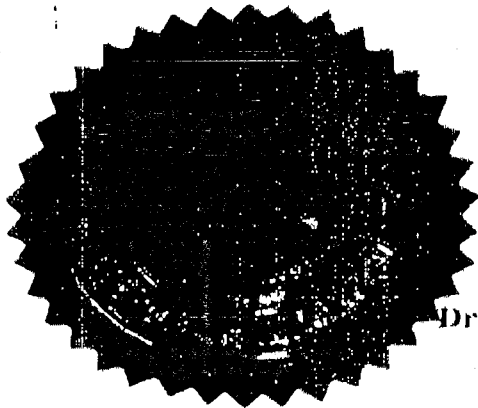
