

## INSTRUMENT OF RATIFICATION

Memorandum of Understanding between the Governments of the Participating Member States of the Association of South-East Asian Nations (ASEAN) of the Pilot Project for the Implementation of a Regional Self-Certification System

WHEREAS the Memorandum of Understanding between the Governments of the Participating Member States of the Association of South-East Asian Nations (ASEAN) on the Pilot Project for the Implementation of a Regional Self-Certification System (hereinafter referred to as "the MoU") was signed by the Government of Brunei Darussalam on 30 August 2010 in Da Nang, Viet Nam.
