LETTER OF ACCEPTANCE

WHEREAS the Memorandum of Understanding between the Governments of the Participating Member States of the Association of Southeast Asian Nations (ASEAN) on the Pilot Project for the Implementation of a Regional Self-Certification System was done at Da Nang on 30 August 2010;

WHEREAS Article 8, Paragraph 7 of the Memorandum of Understanding provides that ASEAN Member States that are not Participating Member States can accede to this Memorandum of Understanding at any time subject to the agreement of the Participating Member States at the level of their representatives to the Senior Economic Officials Meeting;

WHEREAS Pursuant to the said Article, the Memorandum of Understanding shall enter into force for the acceding ASEAN Member States upon the deposit of their instruments of ratification or letters of acceptance with the Secretary-General of ASEAN, who shall promptly inform each Participating Member State of such deposit; and

WHEREAS Brunei Darussalam, Malaysia, the Republic of Singapore and the Kingdom of Thailand who are the Participating Member States to the Memorandum of Understanding, have given the consent to the accession of the Kingdom of Cambodia to the Memorandum of Understanding;

NOW THEREFORE, the Royal Government of Cambodia, having considered the above-mentioned Memorandum of Understanding, hereby accedes to the same and undertakes to faithfully perform and carry out all the stipulations contained therein on 1st August 2015;

IN WITNESS WHEREOF, I have signed this Letter of Acceptance and affixed hereunto the seal of the Royal Government of Cambodia.
