INSTRUMENT OF RATIFICATION

WHEREAS the Protocol to Implement of the Eighth Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services (hereinafter referred to as "the Protocol") was signed on the Twentieth Day of December in the Year Two Thousand and Thirteen;

AND WHEREAS the Protocol was signed on behalf of the Government of the Republic of the Union of Myanmar on the Twentieth Day of December in the Year Two Thousand and Thirteen;

AND WHEREAS Paragraph 4 of the Protocol provides that it shall enter into force on the sixtieth day after the seventh Instrument of Ratification or Acceptance from the ASEAN Members States with the Secretary General of ASEAN;

NOW THEREFORE, I, Wunna Maung Lwin, Union Minister for Foreign Affairs of the Republic of the Union of Myanmar, do hereby declare that the Government of the Republic of the Union of Myanmar, having considered the Protocol, ratifies the same and undertakes to perform and carry out faithfully all the stipulations therein contained;
