**WHEREAS** the **Third Protocol Amending the Treaty of Amity and Cooperation in Southeast Asia** was signed at Ha Noi, Viet Nam on the twenty third day of July in the year two thousand and ten by the representative of the Government of the Republic of India duly authorized for that purpose, which Protocol is reproduced word for word in the Annexure to this document;
