INSTRUMENT OF ACCESSION

WHEREAS the Memorandum of Understanding between the Governments of the Participating Member States of the Association of South-East Asian Nations (ASEAN) on the Pilot Project for the Implementation of a Regional Self- Certification System was done at Da Nang, Viet Nam on 30 August 2010;

WHEREAS Article 8, paragraph 7, of the Memorandum of Understanding provides that ASEAN Member States who are not Participating Member States can accede to the Memorandum of Understanding at any time subject to the agreement of the Participating Member States at the level of their representatives to the Senior Economic Officials Meeting;

WHEREAS pursuant to the said Article, the Memorandum of Understanding shall enter into force for the acceding ASEAN Members States upon the deposit of their instruments of ratification or letters of acceptance with the Secretary- General of ASEAN, who shall promptly inform each Participating Member State of such deposit; and

WHEREAS Brunei Darussalam, Malaysia, the Republic of Singapore and Kingdom of Thailand, who are the Participating Member States to the Memorandum of Understanding, have welcomed to Myanmar's accession to the Memorandum of Understanding.

THE GOVERNMENT OF THE REPUBLIC OF THE UNION OF MYANMAR, having considered the aforesaid Memorandum of Understanding, hereby accedes to the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Accession is signed by the Union Minister for National Planning and Economic Development of Myanmar.
