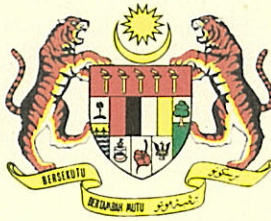
- i) **ASEAN Trade in Goods Agreement;**

## **INSTRUMENT OF NOTIFICATION**

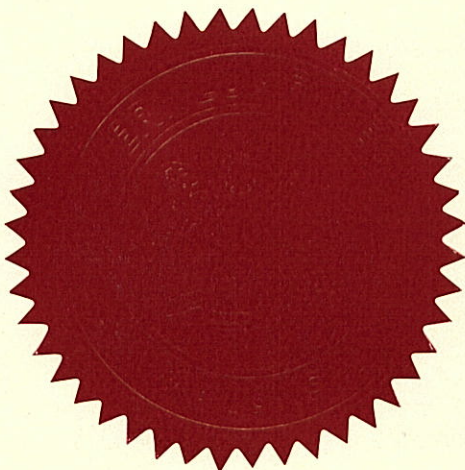
**WHEREAS** the Protocol to Implement the Seventh Package of Commitments under the ASEAN Framework Agreement on Services (hereinafter referred to as "the Protocol") was signed on behalf of the Government of Malaysia on 26 February 2009 in Hua Hin, Thailand;

**AND WHEREAS** Article 7 of the Protocol provides that a Party shall, upon the completion of its internal procedures for the entry into force of this Agreement, notify all the other Parties in writing;
