**AND WHEREAS** pursuant to paragraph 5 of the Protocol that Malaysia has concluded negotiations with Indonesia and has inscribed its commitments in its Consolidated Schedule of Specific Commitments on Financial Services;

**AND WHEREAS** these subsequent commitments under paragraph 6 of the Protocol shall enter into force within ninety (90) days after the date such commitments are notified in writing to the ASEAN Finance Ministers' Meeting on 21 December 2016;

**NOW THEREFORE**, the Government of Malaysia, having considered the Consolidated Schedule of Specific Commitments on Financial Services, ratifies the same and undertakes to perform and carry out faithfully all stipulations therein contained;

**IN WITNESS THEREOF**, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs, Malaysia.

I would like to refer to the above matter.



For your kind information, Malaysia has completed internal procedures of ratification of the Protocol to Implement the Sixth Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services (AFAS) and acceptance for the entry into force of this Protocol. Malaysia is ready to implement commitments therein set out in the Annexes.

3. As stipulated in paragraphs 6,7 and 8 of the Protocol, the implementation of the Protocol and ASEAN Member States' commitments in the Annexes shall enter into force ninety (90) days after the date of its signing which was on **20 March 2015** in Kuala Lumpur and after Member States' have completed their internal procedures of ratification and notified the ASEAN Secretariat in writing. In this regard, please find attached a single original copy (in the English language) of the Instrument of Ratification for the Implementation of the Protocol to Implement the Sixth Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services which was signed by the Minister of Foreign Affairs Malaysia on 2 June 2015 in Putrajaya for the ASEAN Secretariat's further acceptance and entry into force procedures.
