**KNOW YE**, that whereas, the Protocol to Implement the Fourth Package of Commitments under the AFAS was signed on 03 September 2004 in Jakarta, Indonesia; the Protocol to Implement the Fifth Package of Commitments under the AFAS was signed on 08 December 2006 in Cebu, Philippines; the Protocol to Implement the Sixth Package of Commitments under the AFAS was signed on 19 November 2007 in Singapore; the Protocol to Implement the Seventh Package of Commitments under the AFAS was signed on 26 February 2009 in Cha Am, Thailand; the Protocol to Implement the Eight Package of Commitments under the AFAS was signed on 28 October 2010 in Ha Noi, Viet Nam; and finally the Ninth Package of Commitments under the ASEAN Framework Agreement on Services (AFAS) was signed on 27 November 2015 in Makati, Philippines;
