FOR THE THIRD PROTOCOL TO AMEND THE ASEAN COMPREHENSIVE INVESTMENT AGREEMENT (ACIA)

WHEREAS the Third Protocol to Amend the ASEAN Comprehensive Investment Agreement being signed in Hanoi, Vietnam on 20th December 2017,

AND WHEREAS Paragraph 1 of the Article 2 of the Third Protocol specifies that the Third Protocol shall enter into force after all Member States notified the completion of their respective internal procedures for the entry into force of this Protocol to, or, where necessary, deposited instruments of ratification or acceptance with, the Secretary-General of ASEAN.
