INSTRUMENT OF RATIFICATION

WHEREAS Protocol 2 on the Designation of Frontier Posts of the ASEAN Framework Agreement on the Facilitation of Goods in Transit (the "Protocol") was signed on behalf of the Government of the Republic of Singapore at Langkawi, Malaysia, on 4 May 2018;

AND WHEREAS Article 4(3) of the Protocol provides that the Protocol shall be subject to ratification or acceptance by the Contracting Parties, and that the Instrument of Ratification or Acceptance, including the affirmation of their designated frontier posts, shall be deposited with the Secretary-General of ASEAN;

AND WHEREAS Article 4(4) of the Protocol provides that the Protocol shall enter into force on the sixtieth day after the deposit of the sixth Instrument of Ratification or Acceptance with the Secretary-General of ASEAN, and shall become effective only among the Contracting Parties that have ratified or accepted it, and that for each Contracting Party ratifying or accepting the Protocol after the deposit of the sixth Instrument of Ratification or Acceptance, the Protocol shall enter into force on the sixtieth day after the deposit of such Contracting Party of its Instrument of Ratification or Acceptance with the Secretary-General of ASEAN;

NOW THEREFORE I, Vivian Balakrishnan, Minister for Foreign Affairs of the Republic of Singapore, declare that the Government of the Republic of Singapore, having considered the abovementioned Protocol, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained.

IN WITNESS WHEREOF, I have signed this instrument of ratification on behalf of the Republic of Singapore.
