1. Protocol to Implement the Eight Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services (AFAS) signed on 05 April 2019;
2. ASEAN Mutual Recognition Arrangement on Flight Crew Licensing (MRA) signed on 13 October 2017;
3. ASEAN Framework Agreement on the Facilitation of Cross Border Transport of Passengers by Road Vehicles signed on 13 October 2017;
4. Protocol 3 on Domestic Code-Share Rights between Points within the Territory of Any Other ASEAN Member States signed on 13 October 2017; and
5. Protocol to Amend the ASEAN Plus Three Emergency Rice Reserve (APTERR) Agreement signed on 12 October 2018.

INSTRUMENT OF RATIFICATION

TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the *Protocol 3 on Domestic Code-Share Rights between Points within the Territory of Any Other ASEAN Member States* was signed on 13 October 2017 in Singapore:

WHEREAS, the Protocol will further liberalize the key economic elements under the Association of Southeast Asian Nations (ASEAN) Multilateral Agreements on Air Services and on Full Liberalization of Passenger Air Service, and the existing Protocols thereof;

WHEREAS, the Protocol will allow designated airlines of each ASEAN Member State to exercise domestic code-share rights from any city with an international airport in its territory to any city with an international airport in the territory of another ASEAN Member State, provided that there shall be no exercise of cabotage rights; and

WHEREAS, the Protocol will expand air transportation services among ASEAN Member States and will boost connectivity to secondary points in the ASEAN region;

NOW, THEREFORE, be it known that I, **RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, after having seen and considered the *Protocol 3 on Domestic Code-Share Rights between Points within the Territory of Any Other ASEAN Member States*, do hereby ratify and confirm the same and each and every article and clause thereof.
