**INSTRUMENT OF ACCEPTANCE

WHEREAS the Government of the Kingdom of Cambodia signed the Protocol to implement the Eighth Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services in Chiang Rai, Thailand, on 05 April 2019;
