INSTRUMENT OF RATIFICATION OF THE THIRD PROTOCOL TO AMEND THE ASEAN COMPREHENSIVE INVESTMENT AGREEMENT

WHEREAS the Royal Government of Cambodia signed the Third Protocol to Amend the ASEAN Comprehensive Investment Agreement in Ha Noi, Viet Nam, on 20 December 2017;

AND WHEREAS the Article 2(1) of this Protocol stipulates that this Protocol shall enter into force after all Member States have notified the completion of their respective internal procedures for the entry into force of this protocol to, or, where necessary, deposited instruments of ratification or acceptance with, the Secretary-General of ASEAN;

AND WHEREAS His Majesty the King of Cambodia promulgated the abovementioned Protocol on 27 March 2020;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Protocol, hereby undertakes to faithfully perform and carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
