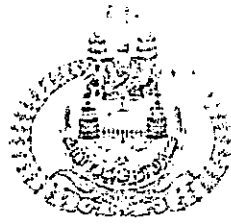

THE ASEAN COMPREHENSIVE INVESTMENT AGREEMENT**

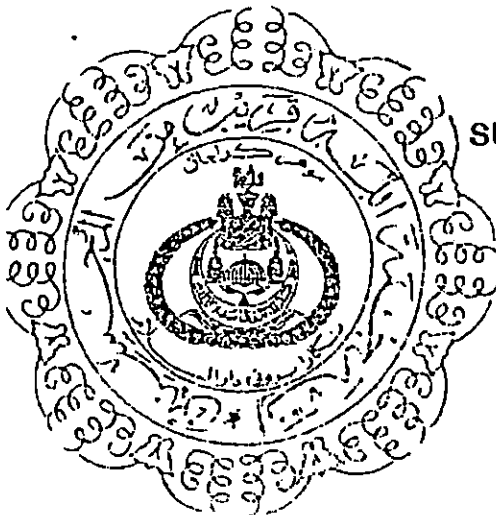
WHEREAS the Fourth Protocol to Amend the ASEAN Comprehensive Investment Agreement (hereinafter referred to as "the Protocol") was signed on behalf of the Government of Brunei Darussalam at Ha Noi, Viet Nam on 15th July, 2020;

AND WHEREAS Paragraph 1 of Article 5 of the Protocol specifies that the Protocol shall form an integral part of ASEAN Comprehensive Investment Agreement and shall enter into force after all Member States have notified the completion of their respective internal procedures for the entry into force of this Protocol to, or, where necessary, deposited instruments of ratification or acceptance with, the Secretary-General of ASEAN;

NOW THEREFORE I, SULTAN HAJI HASSANAL BOLKIAH MU'IZZADDIN WADDAULAH, Sultan and Yang Di-Pertuan of Brunei Darussalam, declare that the Government of Brunei Darussalam, having considered the Protocol, hereby ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained;

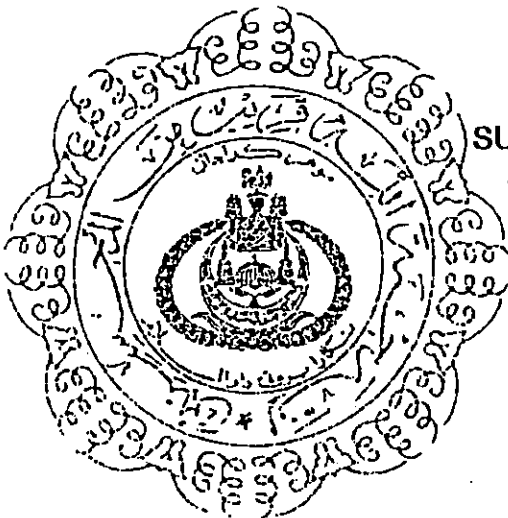
