## INSTRUMENT OF RATIFICATION

## TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

**KNOW YE**, that whereas, the Association of Southeast Asian Nations (ASEAN) Protocol on Enhanced Dispute Settlement Mechanism ("EDSM Protocol") was signed by the ASEAN Economic Ministers on 20 December 2019 in Manila, Philippines;

WHEREAS, the EDSM Protocol builds upon the provisions of the 2004 ASEAN Protocol on Enhanced Dispute Settlement Mechanism which was signed on 29 November 2004 in Vientianne, Lao People's Democratic Republic;

WHEREAS, the EDSM Protocol aims to improve and strengthen the dispute settlement mechanisms of the ASEAN, consistent with a rules-based ASEAN community; and

WHEREAS, the EDSM Protocol is expected to benefit the Philippines and other ASEAN Member States by providing the flexibility to bring disputes involving violations of obligations under the covered agreements listed under the Protocol's Appendix I, as well as future ASEAN economic agreements, either before the Dispute Settlement System of the World Trade Organization or under the EDSM Protocol;

NOW, THEREFORE, be it known that I, RODRIGO ROA DUTERTE, President of the Republic of the Philippines, after having seen and considered the Association of Southeast Asian Nations Protocol on Enhanced Dispute Settlement Mechanism, do hereby ratify and confirm the same and each and every article and clause thereof.
